JLP Bylaws Article V Section1.c.

Dues shall be payable according to the current class of membership unless a written request for a change in status is made to the Office Manager or Membership Director and postmarked on or before April 1. Provisional members shall be liable for dues and Provisional fees immediately upon acceptance of the invitation to membership. The Treasurer shall notify the membership of their annual dues obligation on or before February 15. Members whose dues are not postmarked and/or delivered by April 15 shall be sent final written notice from the Treasurer stating the total amount due, including a 20% late penalty. Any member who fails to make payment in full, including penalty, within 30 days following the date such notice is postmarked shall be automatically removed from membership.

Refunds of dues will not be made to members or provisionals who resign during the fiscal year, to members who have been removed from membership or to Provisionals who fail to meet the requirements.
